Details about local resources	<p>We currently have one sweeper operator. If the applications are funded, the existing sweeper would be maintained as a reserve unit to cover operations when other sweepers are out of service. The Public Works Director would continue operating one of the sweepers, while the additional unit would be assigned to staff who would require training in its operation.</p> <p>Public Works is composed of eight staff members who would be trained not only in sweeper operation but also in performing routine maintenance.</p>

Geographical area that the requested street sweeper will operate	<p>The sweepers will operate throughout the Town of Guadalupe, following a routine that covers both arterial and residential roads to ensure the entire community is serviced. The service area encompasses the Town's incorporated limits, totaling approximately 0.67 square miles.</p> <p>Each sweeper will cover half of the arterial roads and half of the residential roads. The total arterial lane miles are 4, and the total residential lane miles to be swept are 14. Therefore, each sweeper will be responsible for 2 arterial lane miles and 7 residential lane miles.</p>

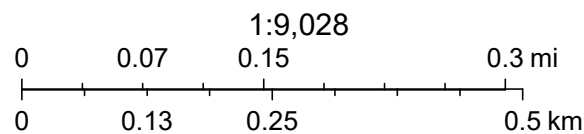
